TERMS AND CONDITIONS

Information on how to enter and participate forms part of these Terms and Conditions. Participation in the 'Craigieburn Central Birthday Cash Machine' Promotion 2025 is deemed acceptance of these Terms and Conditions.

WHO CAN PARTICIPATE?

1. Subject to Condition 2, this Promotion is open to people aged 6 years and over.
2. Parent/carer must be present for people under the age of 18 years in order for them to participate in the Promotion.

PROMOTION PERIOD

3. This Promotion will run from 12:00pm until sold out, or until 7:00pm, whichever occurs first, on Saturday 29th and Sunday 30th November 2025 ('Promotion Period').
4. Participation in the Promotion is not offered outside this Promotion Period.

ELIGIBILITY DETAILS

5. To be eligible to participate in the Promotion, all Participants must:
 - a. Spend \$50 or more at any Craigieburn Central retailer between Monday 25th and Sunday 30th November 2025
 - b. Present a physical copy of their valid receipt(s) to the Promotion staff at the Promotion location (near Kmart) to be hole punched
 - c. Follow the Cash Grab Rules displayed at the Promotion location/ as listed below:
 - i. Craigie Bucks must be caught with the participants hands, use of clothing, bags, or any other devices not permitted.
 - ii. Craigie Bucks cannot be picked up off the floor or glass.
 - iii. Only Craigie buck caught within the 15 seconds the machine is running will be valid. Anything caught after the buzzer is ineligible to be included.
6. Participants must complete all steps listed above, or risk having their entry denied.
7. Multiple entries are permitted as long as a new/valid receipt(s) is presented to Promotion staff. Receipt(s) cannot be used for multiple Participants. Receipts will be marked once used to enter a Promotion.
8. The Promoter's directors, management, employees, retailers, tenants of participating centres in addition to agencies and suppliers associated with this Promotion are ineligible to enter.
